


Celebrating 130 years!

Minimum Required IRA Distributions - Tax Free Charitable Gifts

If you are at least 70½ years of age, you are eligible to take advantage of a simple way to benefit at-risk families and abuse victims through a gift to the Foundation for Children & Families of Iowa and receive tax benefits in return. You

can give up to \$100,000 from your IRA directly to a qualified charity such as ours without paying income taxes on the money. For more information visit the planned giving section of our website at www.cfiowa.org.

This law no longer has an expiration date making it possible for eligible donors to utilize this benefit annually.
