#### **Helping a Mother Learn How to Heal**

Wendy\* is a 35-year-old woman who experienced significant trauma in her childhood and domestic violence in her relationships as an adult. As a mother of five who was expecting her sixth child, she became involved with the department of human services and had experienced the removal of her children from her care. Wendy and her oldest child, Nathan, began working with the CFI behavioral health program after an internal referral was made by their CFI case worker to address their mental health needs.

Wendy was struggling with anxiety, low self-confidence and was experiencing suicidal thoughts after her children were removed from her care. Wendy began services with her focus on reunification. However, Wendy's personal traumatic experiences as a child resulted in difficulty for her to see the impact of her own unhealthy adult relationships and its effects on the parenting of her children.

Initially, Wendy was resistant to therapy as she had a long history of services throughout her childhood that she did not find helpful. Wendy identified that the moment she began to realize that CFI's therapy services could be helpful was after her mental health therapist explained the effects of trauma on the brain and body responses. This education through her therapist allowed Wendy to realize that her

responses were a result of what happened to her when she was younger. Wendy gained insight into her own behavior and responses and began to heal from these experiences for the first time in her life. Wendy became more open to therapy and began to implement changes that would not only benefit her, but would assist in healthy and safe parenting for her children.

#### Helping a Mother Learn How to Heal

Wendy became more comfortable asking for help and advocating for herself and her children's needs. As a result, Wendy's children began to engage in therapy services with providers at CFI and Wendy began Child Parent Psychotherapy (CPP) services with her youngest daughter to heal from the removal and increase confidence in Wendy's parenting. Wendy and her five children were able to all be served in one location at CFI where the staff were able to coordinate services, attend family team meetings and provide collaborative reports for the court to outline Wendy's progress and support her toward reunification with her children. When Wendy gave birth to her sixth child, a baby girl, she was able to maintain custody due to the progress she had made in stabilizing her own mental health needs.

She then terminated her abusive relationship, gained stable housing and secured employment in order to support her family. Wendy was later successfully reunified with her children and their DHS case was recommended for closure.
