In 1888, a committed group of educators, ministers and stakeholders in Davenport, Iowa started what was called the Iowa Education Aid Association with the mission of placing homeless, abused and neglected children in childless homes. Over the past 130 years, Children & Families of Iowa has maintained this tradition of *Restoring hope*, *Building futures and Changing lives* of children, adults and families throughout the state of Iowa.

The organization continues to evolve and transform to meet the everchanging needs of individuals and families, utilizing the most innovative and effective approaches to move people from hopeless to hopeful. As an agency with a long history of family focused services, we have responded to the community in its need for additional community based services. This includes the expansion of mental health and substance abuse services for adults. We have seen positive results and are invested in making a difference in the lives of those we touch through our family focused services and advocacy efforts.

During fiscal year 2017-2018, we impacted the lives of over 38,000 individuals within the 99 counties of Iowa. To note a few accomplishments over the past year:

- The Connect 2 Careers program expanded its services and moved to a new location. This move increased the accessibility of workforce and career planning services for young adults between 14 24 years old residing within an eight county area.
- The statewide Parent Partner program continues to grow and receive accolades for its innovative and successful results in keeping kids safe and reuniting families through mentoring. The program touches the lives of over 1,200 parents per year. The program is currently consulting in 30 states regarding the positive outcomes achieved through the mentoring model.

Our accomplishments and success would not be possible without the leadership of our committed and generous Board of Directors, Board of Trustees, devoted volunteers, and qualified staff that support our mission. We are proud of the work that is being done here in Iowa and hope to continue to do this work for the next 100 years. Thank you for your on-going support of the families that we serve.

OUR MISSION

Children & Families of Iowa (CFI) strives to **restore hope**, **build futures**, and **change lives** for Iowa's most vulnerable children and families. CFI accomplishes this mission through the following family-centered, evidence-based, interconnected program areas:

CFI PROGRAM AREAS

Domestic Violence Services

Emergency shelter; food, clothing, transportation, and support groups for victims and their children.

Teen Programs

Services for teens who are not well-equipped to manage the transition to adulthood. CFI helps these teens through outpatient mental health and substance abuse services, workforce readiness programs, mentoring, and childcare.

Family Support Programs

In-home programs that provide education, training and access to resources for families in crisis.

Early Childhood Development Services

Child Development Center for low-income families with children ages two weeks to 10 years. Therapeutic classrooms designed to serve children with special needs.

Mental Health and Substance Abuse Services

CFI provides mental and behavioral health services for individuals of all ages and families, delivered by licensed mental health professionals.

CFI also provides substance abuse services for individuals of all ages, designed to halt the progression of alcohol and substance abuse at its earliest stages, before chronic dependency sets in.



amie* has dealt with domestic violence since she was young. "My parents let my boyfriend move in when I was just 15 years old. I was in love, and eventually we married. We had three children together and all I wanted was for us to be a happy, storybook family," explains Jamie. "I was so young and vulnerable, I didn't realize how destructive our relationship had become."

After divorcing the father of her three children, Jamie entered into yet another more abusive relationship. "After Joe* punched me in the mouth, I lost all my front teeth. I was scared he would kill me or harm the children. I was afraid of Joe, but more afraid I couldn't take care of the children without him. I was terrified of us becoming homeless. How could I even look for a job with no front teeth?" Searching for hope, Jamie and her children entered Children & Families of Iowa's (CFI) shelter for victims of domestic violence. As a result of CFI's program and community support, Jamie began to deal with the significant abuse and adversity stemming from her past abusive relationships.

"Initially, I even distrusted my domestic violence advocate, but together we worked diligently to overcome

my lack of trust in others. Now, we have a good connection. I have learned to set healthy boundaries in my relationships and am empowered to do the everyday tasks I was not allowed to do before, with confidence." She now has her own apartment, and with the help of her advocate, is working on getting partial dentures to fix her teeth. "I know that having my smile back will increase my confidence and continue to drive my progress." Through CFI's domestic advocacy program, Jamie has been able to improve her mental health and take charge of her life.

Jamie is only one of over 6,000** victims of domestic violence in Iowa each year. Those lucky enough to escape their abusers, often come to shelter on such short notice they only bring what they can carry.

Children & Families of Iowa depends on community support to provide safe shelter and advocacy to victims 24 hours a day, 7 days a week, 365 days a year.
