OUR MISSION

Children & Families of Iowa (CFI) strives to *restore hope*, *build*

futures and *change lives* for Iowa's most vulnerable children and families. CFI accomplishes this mission through the following family-centered, evidencebased program areas:

PROGRAM AREAS

Domestic Violence Services

Emergency shelter, outreach, advocacy, education, food, clothing, transportation, and support groups for victims and their children.

Work Readiness Programs

Job market preparation for youth and adults who are currently unemployed or under employed. CFI helps these individuals through career pathway planning, work readiness training, connections to local employers and training programs, paid and unpaid work experiences, outpatient mental health and substance abuse services, mentoring, and child care.

Family Support Programs

In-home programs that provide education, training and access to resources for families in crisis.

Early Childhood Development Services

Childcare for low-income families with children ages two weeks to 10 years. Therapeutic classrooms designed to serve children with special needs.

Mental Health and Substance Abuse Services

Mental and behavioral health services for individuals of all ages and families, delivered by licensed mental health professionals.


Substance abuse services for individuals of all ages, designed to halt the progression of alcohol and substance abuse at its earliest stages, before chronic dependency sets in.



Katie's Story

atie* reached out to Children and Families of Iowa's (CFI) Domestic Violence Shelter and Services after she was brutally assaulted by her husband (Joe*) of 29 years. "Neighbors heard yelling and crashing sounds from our apartment and called the police," explained Katie. The police took Katie to the hospital for treatment and observation. "I was discharged from the hospital the next day suffering a concussion, a black eye, and cuts to my lip. I was fortunate not to have any broken bones," said Katie. A CFI outreach advocate met her at the hospital (following strict COVID 19 rules) and brought her an emergency phone and some personal supplies. Katie, as most victims of domestic violence, left the situation with nothing more than what she was wearing. "My friends let me stay with them for a few days so they could take care of me while I healed." Joe had been arrested but was bailed out by a family member only hours after the arrest. A no contact order was immediately put in place. CFI's outreach advocate discussed safety planning with Katie. "I learned to use a safe word with friends and my support network to alert them if I was in danger. I didn't believe that Joe would comply with the no contact order." CFI's outreach advocate suggested that Katie consider coming to CFI's domestic violence shelter since she no longer felt safe at home.

"I had been with Joe since I was a teenager and had never lived on my own," said Katie. "Joe would not let me learn computer skills, have a job, or have knowledge of or access to our finances. I was frantic. How would I survive on my own? My marriage caused a rift between me and my family, including our adult children. I did not know how to pay bills. Joe paid all the bills, the rent, and bought all the groceries. He barely allowed me to leave the house," said Katie. She found out from distant family members that Joe was staying at a motel, and his father was paying for it. This knowledge made Katie angry. "Joe always lands on his feet, and I was left with nothing but stress, and emotional and physical pain. I was angry with myself because I still loved Joe, despite years of abuse." Her CFI advocate provided her with information about the cycle of violence and how it takes an average of seven to nine attempts to leave a relationship where domestic violence is present. They discussed domestic violence

warning signs, and the use of power and control in an abusive relationship. "I finally realized that Joe abused me physically, sexually, financially, and emotionally. He was an expert at using isolation, and coercion. Joe did his best to deplete my self-esteem," explains Katie.

CFI's Domestic Violence Shelter and Services was able to secure funding to help pay Katie's rent. "With CFI's guidance, I was able to set and accomplish short term goals for myself including learning some basic computer skills, establishing an email account, and securing employment. I currently work full time. Thanks to CFI's encouragement, I have set up a savings account and am studying for my driver's license for the first time. Most importantly, I realize that I deserve to be happy and safe," said Katie.

Children & Families of Iowa depends on community support to provide the services Katie and over 26,000 Iowans desperately need to ensure that they can find the support they need to live a happy and healthy life.
