INDIVIDUAL STORIES

Since being enrolled at CFI's Therapeutic Child Care program (TCC), Dillon's* teachers, mental health consultant, and mom have seen a great improvement in his behaviors. The program's smaller class size and excellent ratio allowed him to receive the individualized attention he needed to work through his challenges. While in the program, he has learned coping skills, what to do with his feelings when he is feeling frustrated and how to ask for help. Rather than acting out aggressively or being destructive, he is now able to take time away from the group activity and verbalize his feelings. He has also been able to learn social skills that have allowed him to build friendships with the children in his classroom.

Through CFI's Domestic Violence Service (DVS) outreach Sabrina* learned how to make a safety plan, recognize healthy relationships, set boundaries, and the warning signs of abuse. Along the way, she began to value herself as a person. She has also learned that the adverse experiences she had as a child, and the experiences that her children were living through were affecting all of the family's mental health and stability. Through counseling she was able to set realistic goals for herself.

Sabrina is one of the lucky ones; she understood that she needed to connect with domestic violence outreach services. Many are not so lucky. In a 24-hour Iowa survey of all 22 agencies providing domestic violence services, which took place on September 7, 2022, victims of domestic violence made 57 requests for service that could not be met because of the lack of resources to meet victim's needs. (Domestic Violence Counts, Iowa Summary).

"I started out using individual therapy services at CFI. I now utilize a family therapist with my family so that we can repair and maintain our relationships. The improvements made in our lives have been tremendous. I have not only learned a lot about myself, but about my family too. I have come to terms with certain things in my life, and have more confidence in myself. I look forward to my weekly sessions, and find they put me in a better mood and help deal with daily stressors more effectively. I feel like a weight is lifted from my shoulders every time I walk out the door."

Consuela* had been in and out of trouble most of her life. A lack of parental supervision had left her with no direction and lots of time to get into trouble. With the goal of finding a better job than the fast food industry, Consuela signed up for one of CFI's summer work readiness workshops. "During the four week workshop I did a lot of reflecting, and decided that I was ready for a change. I finally found the support and accountability I needed through CFI." Consuela has now gained full-time employment in the human services field.
